#### 13.1 Drainage

Ms. Carriere reported that the culvert replacement work on Road 117.5W had been completed. She noted that she would enquire with Mr. Sheffield from NextGen concerning tile drainage for certain sections of roads that would benefit from same and would request the presentation.

Ms. Carriere stated that the Environmental Officer had conducted an inspection of the facility and lagoon June 30, 2022. In conversation with the officer, it was discussed that the facility was not in good shape and had strong concerns with the oil, oil containers etc. onsite and that a cleanup would need to happen in the very near future and an engineer's report is required to determine the state of the soil. In addition, she noted that the lagoon had an area that was in disrepair and required attention. In closing, she advised that a report would be provided shortly from the Environmental Officer and would provide same.
