7.1 By-law No. 2025-05 - to Amend the Zoning By-law - 1st Reading

That By-Law No. 2025-05 - To Amend the Zoning By-Law 2021-04 be given first reading.

8 SUBDIVISION

8.1 Subdivision 4202-25-8756 - Orr - 107 Montrose Street

Whereas Kelvin Orr on behalf of KSO Real Estate LTD., registered owners of 107 Montrose Street, SW 17-10-21W, Lots 18 and 19, block 24, Plan 23 BLTO (0.29 acres) made an application for subdivision;

The intent of the application is to subdivide the urban property into two (2) lots by severing off the existing single-family dwelling and accessory shed to allow for future residential development of the undeveloped lot;

Therefore, be it resolved that Subdivision File No. 4202-25-8756 be approved with the following conditions:

1. That the applicant obtain a variance order for proposed Lot 2 to decrease the allowable site width from 50 feet to 39 feet within the "RS" Residential Serviced

Zone to ensure compliance with the Zoning By-law;

- 2. That the single lot subdivision fee of \$110.00 be paid to the Rural Municipality of Whitehead;
- 3. That a financial levy of \$750.00 be made to the Rural Municipality of Whitehead Capital Reserve Fund for the creation of a new title as per By-law No. 2111;
- 4. That any new or restored survey monuments required due to the subdivision are to be paid by the applicant.
- 5. That the applicant remove or modify the existing deck to meet the side yard requirements or obtain a variance order to allow for a reduced side yard for an accessory structure from 3 feet to 1 feet in the "RS" Residential Serviced Zone to ensure compliance with the Zoning By-law.

### 8.2 Subdivision 4202-25-8754 - Amend Conditions

And whereas a clerical error had included the existing property title when calculating fees due to the municipality and the fees required by by-law are to be paid for the generation of any new titles;

Therefore, be it resolved that the RM of Whitehead requests the Community Planning office revise Council's conditions 4 and 5 for Subdivision File No. 4202-25-8754 to read as follows:

- 4. That the multi lot subdivision application fee in the amount of \$540.00 (\$270.00 x 2 lots) be paid to the Rural Municipality of Whitehead as per the Annual Schedule of Fees By-law.
- 5. That a financial levy of \$1,500.00 (\$750.00 x 2 lots) be paid to the Rural Municipality of Whitehead Fire Capital Reserve Fund as per By-law No. 2111.

Council discussed recent inquiries from rural residents with respect to the dust control policy. No changes were proposed, however, Council expressed interest in approaching neighboring service providers for discounted rates to Whitehead residents.

WHEREAS, 261 railway crossing and trespassing incidents occurred in Canada in 2024; resulting in 68 avoidable fatalities and 58 avoidable serious injuries;

WHEREAS, educating and informing the public about rail safety (reminding the public that railway rights-of-way are private property, enhancing public awareness of the dangers associated with highway rail grade crossings, ensuring pedestrians and motorists are looking and listening while near railways, and obeying established traffic laws) will reduce the number of avoidable fatalities and injuries cause by incidents involving trains and citizens;

AND WHEREAS Operation Lifesaver is a public/private partnership whose aim is to work with the public, rail industry, governments, indigenous communities, police services, media and others to raise rail safety awareness;

WHEREAS CN and Operation Lifesaver have requested City Council adopt this resolution in support of its ongoing efforts to raise awareness, save lives and prevent injuries in communities, including our municipality;
