**WHEREAS** Section 130 of The Municipal Act provides authority for municipalities to establish one or more positions to carry out the powers, duties and functions of a designated officer under a by-law of this or any other Act, and may give each such position any title the Council considers appropriate;

**AND WHEREAS** Section 131 of the Act provides authority for a designated officer to delegate to an employee of the Municipality a power, duty or function given to the officer under a By-Law or Act;

**AND WHEREAS** the Council of the Rural Municipality of Whitehead deems it necessary to establish certain designated officer positions and to provide to said officers the authority to delegate certain powers, duties and functions to Municipal Employees of the Rural Municipality of Whitehead;
