## 9.1 Subdivision Application 4202-22-8392 - Kenzie Gray

#### 12.3 Grand Valley Road Speed & Safety Concerns

Whereas the residents of the Grand Valley Road area have expressed concerns over the safety, semi traffic and speed issues on the roadway.

And Whereas a fatality occurred on the Grand Valley Road that is located within the Rural Municipality of Whitehead on May 22, 2022.

Therefore Be It Resolved that the Rural Municipality of Whitehead Council requests Manitoba Infrastructure initiate a review of the speed limit on provincial highway 459. **CARRIED** 

#### 12.4 Rail Safety Improvement Program

Whereas Transport Canada's Regulations on railway crossing standards had been amended to ensure safety at all crossings throughout Canada. And Whereas the Canadian Pacific Railway Crossing located on Haggerty Street in Kemnay had been a safety concern according to the new regulations. And Whereas the Rural Municipality of Whitehead in consultation with CP Rail, applied for a Rail Safety Improvement Program grant to provide funding to ensure the project met regulations.

Therefore Be It Resolved that the Rural Municipality had been approved for funding under the Rail Safety Improvement Program in the amount up to \$288,000.00 for road improvements to comply with regulations. **CARRIED** 

## 12.5 Dumbarton Demolition Request for Proposals

Whereas a Request for Proposals for the Dumbarton Demolition was advertised with a closing date of June 10, 2022 at 1:00pm.

And Whereas questions were raised concerning waste disposal tipping fees and determining costs for submission.

And Whereas all companies whom submitted a RPF were contacted to remove waste disposal tipping fees from their submissions

And Whereas three RFP's were received:

JRW Contracting Ltd. total bid \$43,518.00 (without tipping fees) Hodgson Construction Inc. total bid \$10,900.00 (without tipping fees) Tri-Wave Construction Ltd. total bid \$9,314.72 (without tipping fees)

Therefore Be It Resolved that Tri-Wave Construction Ltd. is awarded the Dumbarton Demolition (excluding tipping fees) with the submitted total bid of \$9,314.72.

#### 13.1 Drainage

Ms. Carriere advised that the following culverts had been replaced RD 117.5 and RD 114. She noted that the other culvert on RD 114 had been damaged by a RF Now fibre line that was bored through the culvert and that Mr. Willman and herself were in contact with RF Now for replacement of same.

#### 13.2 Fire & Emergency Services

Ms. Carriere noted that a committee meeting was held with Fire Chief Crosson and Reeve Sutherland in attendance. She noted that it was decided that she would prepare the proposal for fire practise to take place during waste facility hours. In speaking with the Environment Officer for the area, it would be doubtful that the proposal to burn items while the facility was open would be approved but would require a proposal letter to operate training exercised whether burning or not and while open to the public or not.

#### 13.3 Waste Management Facility

Ms. Carriere reported that clean-up was still in progress at the Facility.

#### 13.4 Machinery

Ms. Carriere noted that no bids were received for the old Schulte mower and that Councillor Bokkel suggested Fraser Auction Services. She added that the mower sold for \$12,750.00 and that the municipality would receive same less auctions fees.
